### Invitation for Tender

17th January, 2017

1. This Invitation for Tenders follows the General Procurement Notice for Ministry of Water and Irrigation that appeared in the **Mwananchi & Daily News Papers of August, 2016.**
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the **Kilosa Township** during the financial year 2016/2017. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for **Improvement of Water Supply Service in Kilosa Township.**
3. **MORUWASA** now invites sealed Tenders from eligible contractors registered or capable of being registered in **Class Seven (VII)** and above for carrying out the major works under this contract, which include:  
**Supply and installation of pipes and fittings for a distance of 3647m, Supply water flow meters, Supply and install submersible Pump.**
4. Tendering will be conducted through the **National Competitive Tendering Method** Specified in the Procurement Regulations, 2013 – Government Notice No.446 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary to the MORUWASA Tender Board, Mazimbu Road, P. O. Box 5476, Morogoro town, from 7:30 am to 15:00 p.m.** on Mondays to Fridays inclusive except on Public Holidays.
6. A complete set of Tendering Document(s) in **English** and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tshs.100, 000/= (Tanzania Shillings One Hundred Thousand Only)**. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to the **Managing Director, Morogoro Urban Water Supply and Sanitation Authority, P. O. Box 5476, Morogoro.**
7. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.
8. All Tenders in one original plus **two (2)** copies properly filled in, and enclosed in plain envelopes must be delivered to: **PMU office, Morogoro Urban Water Supply and Sanitation Authority (MORUWASA), P. O. Box 5476, Morogoro at or before 10.00 am Local Time, on Friday 17th February, 2017.** Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **PMU office, MORUWASA, Mazimbu Road, Morogoro Municipality.**
9. The Site visit shall be held at **10.00 am Local Time on Wednesday 01st February, 2017,** convening place will be at the **Kilosa Urban Water Supply & Sanitation Authority.** The costs of visiting the site shall be at the tenderer's own expenses.
10. Late Tenders, portion of Tenders, electronic Tenders, and Tenders not received, Tenders not opened at the Tender Opening Ceremony shall not be accepted for evaluation irrespective of the circumstances.
